Approval of Minutes

- Linda read the minutes. Motion by Sharad, second by Linda. **Approved unanimously.**

Financial Review

- Discussed annual insurance payment (paid in full, not monthly).

• **Old Business**

• **Tempe Grant & Landscape Plan:**

- Reviewed grass and plant maintenance.
- Board will inspect proposed grass areas.
- City grant covers **\$20,000**; any excess to be covered by the HOA.
- Project completion deadline: **1 year**.

• **Sewer Lining Updates:**

- Compared **Nu-Flow vs. Peerless** bids (**\$192,900** remains unchanged).
- Nu-Flow provided a job map; identified a necessary **urinal replacement** in the pool house.
- Awaiting updated bid from Nu-Flow before final decision.
- Discussion on concrete removal—unclear if Nu-Flow includes it; Linda confirmed they will repair with concrete.

New Business

• **Cabinet, Drywall & Sink Repairs for Cast Iron Pipe Replacement:**

- HOA to cover **drywall/stucco & plumbing repairs**.
- Homeowners responsible for additional repairs.

• **Pigeon Netting (Units 224 & 240):**

- Compared original bid vs. New Look Restorations (**lower cost**).
- Discussed setting a **\$2,000 approval threshold** (no 2nd bid required below this amount).
- No budget line item; **vote postponed** to next meeting.

• **Roofing Bids (Units 218 & 234):**

- No second bids received; **decision deferred**.
- Chris to follow up with contractors.

• **Termite Control:**

- Linda to meet with **Total Pest Elimination & Great Western Pest Control** to assess damage and cost.
